ELECTRIC AND WATER UTILITY ASSISTANCE (LIHEAP/LIHWAP) | ELIGIBILITY REQUIREMENTS:

- Reside in Palm Beach County
- Have a utility bill in a household member's name
- Total household income must be at or below 60% State Median Income or 150% Federal Poverty Level Guideline
- Must have a copy of the Utility Bill

**RENTAL ASSISTANCE - PRIORITY IS GIVEN TO PREVENTING EVICTION/HOMELESSNESS
REQUIRED DOCUMENTS TO APPLY:**

- Valid government-issued ID for tenant
- Proof of Palm Beach County residency
- Social Security cards for all households members
- Birth certificates for children under 18
- Proof of income for all adults 18 years old and older living in the household
- Proof that loss of income occurred during Covid-19 pandemic (i.e. underemployment or fewer hours during Covid-19 reflected in paystubs, correspondence from employer showing Covid-related reduction in hours, income, layoff, self or household member diagnosed with Covid-19 resulting in reduced hours or loss of income, or increase in expenses)
- Copy of lease agreement (landlord's name, email, and phone number)
- People receiving food stamps need to bring proof

****Households receiving funding or subsidy under any other federally funded rental assistance program (i.e. Section 8, HUD Housing, and Public Housing) MUST also bring: (1) proof of assistance received from such program and (2) proof of rental reduction request to its Housing Authority.*
