- 1. Complete a full registration in Employ Florida at **www.employflorida.com** and obtain a username (Note: You will need to enter this username when you complete the next step).
- Complete the WIOA Scholarship application on CareerSource Palm Beach County's website www.careersourcepbc.com – on the Training Opportunities page found under the Job Seekers tab on the navigation menu at the top of the webpage.
- 3. You will be asked to provide documentation that verifies the qualifying requirement which may include, but not be limited to:
 - Driver's License or State Photo ID
 - Social Security Card
 - Selective Service Registration
 - DD 214 with honorable discharge (for consideration of priority of service)
 - Unemployment Insurance if a state other than Florida
 - Layoff notice, if applicable
 - Pay stubs
 - Up-to-date resume
