Pay Early and Save

Take advantage of these discounts when you pay your property tax early. Discounts are determined by date the payment is received.

- 4% discount when paid November 1 November 30
- 3% discount when paid December 1 January 2
- 2% discount when paid January 3 January 31
- 1% discount when paid February 1 February 28

Please note there is no discount in March. Taxes are delinquent April 1 and will be subject to substantial interest and fees.



Pay Online

Avoid a trip to a service center and skip the wait in line! Visit <u>www.pbctax.com</u> and enjoy the convenience of paying online. Make your payment using eCheck (it's free!) or a credit card. We accept Visa, MasterCard, American Express and Discover. A 2.5% (\$2.00 minimum) convenience fee will apply. Convenience fees are not retained by the Tax Collector's office.

Mailing a Payment? Don't Let It Get Rejected!

Every year we process thousands of payments daily using specialized, high-speed equipment. And every year our equipment rejects a significant number of payments, causing posting delays. Don't let this happen to your payment!

Please follow these instructions to ensure your payment is processed quickly.

- ✓ Do not tape, fold, staple or paper clip your payment.
- ✓ Do not write on the payment stub.
- ✓ Always use the enclosed return envelope.
- ✓ Detach the payment stub and return it with your payment.
- ✓ Write the Property Control Number (PCN) on your payment.

Always remember to include enough time for U.S. Postal Service delivery. We anticipate mailed payments will take approximately 10 - 12 business days to process during <u>Property</u> <u>Tax</u> Season (November – March).
