This full time professional position is responsible for managing activities for Miami-Dade, working proactively with diverse partners to fulfill the mission of Allegany Franciscan Ministries. Responsible for leading the Common Good Initiative in Overtown and operating the regional office. Plans, directs, implements and evaluates community engagement, and other investment opportunities. Develops, implements and continuously evaluates short- and long-term plans to ensure consistency and support for the Common Good Initiative goals. Provides leadership and support to the residents and stakeholders of the Overtown Common Good Initiative community by creating opportunities, developing strategies and making investments that lead to a healthier, safer and more prosperous community. Works independently in the region, communicating regularly with central office staff in Palm Harbor FL and with Vice Presidents for two other Florida regions. Reports to the President & CEO.

Allegany Franciscan Ministries is a non-profit Catholic organization inspired by the Franciscan Sisters of Allegany to improve health for those who are marginalized and underserved. A member of Trinity Health, Allegany has 8 staff, and offices in Tampa Bay, West Palm Beach and Miami. Since 1998, Allegany has invested over \$76 million to 1400+ organizations to improve access to health and health care. While continuing its more traditional grant-making activities, in 2014, Allegany launched the Common Good Initiative, a long-term, community-driven, place-based effort mobilizing communities towards better health and wellness. Through the initiative, Allegany supports residents and stakeholders to create opportunities, develop strategies and make investments that lead to healthier, safer, and more prosperous places.

Requirements

Qualified candidates will have a Bachelor's degree (Master's Degree strongly preferred) plus at least five years experience working in a nonprofit or philanthropic setting with management, community organizing and leadership responsibilities. The successful candidate will share Allegany's values of reverence, commitment to those who are poor, justice, stewardship, and integrity. Important skill sets include solution-oriented problem-solving skills, superior communication skills, ability to envision and articulate a compelling vision for the future, experience with the public, private and independent sectors, knowledge of program funding and community investment processes, and an ability to independently handle multiple priorities and deadlines.
