Epstein Grand Jury Records Bill Becomes Law, Effective July 1



Clerk Abruzzo was in Tallahassee in February, working with Senator Tina Polsky and Representative Peggy Gossett-Seidman to [craft a bipartisan bill](#) to create a pathway for a judge to release the grand jury records in the Epstein case.

On Thursday, February 29, Governor Ron DeSantis [signed the bill in Palm Beach](#).

"Today is a victory for full transparency in the Jeffrey Epstein case," Clerk Abruzzo said. "It is an extremely important day for Jeffrey Epstein's victims, and for our community. The legislation signed today by Gov. Ron DeSantis will, for the first time, create a pathway for a judge to release

the grand jury records in the Epstein case."

Beware of Calls and Texts About Missing Jury Duty

Palm Beach County residents should be aware of scammers attempting to solicit money or personal information from them by claiming they have missed jury duty.

In one recent scam, a caller falsely identifies herself as a law enforcement officer and says the individual has missed jury duty and must post a bond for a bench warrant. The scammer used the names of judges and law enforcement personnel.

If someone calls and demands money, threatens you or has a sense of urgency, **it may be a scam.**

Love Was in the Air on Valentine's Day




