Health Coverage for Children Up to Age 19

Over 10,000 Statewide Enrollments since July!

When the five-year wait rule was eliminated on July 1, 2016 the door was opened for thousands of children to be enrolled in Florida KidCare for as little as \$15-20 a month. Did you know about this rule change? Read more [here](#). Children who are newly eligible for immediate coverage are:

Lawful Permanent Resident (LPR)	Deferred Enforcement Departure (DED)	Applicant for LPR
Paroled into the US for at least one year	Deferred Action	Applicant for Asylum

Battered Child or Child of Battered Person	Paroled into US for less than one year	Applicant for Special Immigrant Juvenile Status
Granted Relief under the Convention Against Torture (CAT)	Individual with non-immigrant status	Applicant for Victim of Trafficking VISA
Temporary Protected Status (TPS)	Administrative Stay of Removal	Applicant for Withholding of Deportation or Removal
Lawful Temporary Resident	Family Unity	To view a description of each status, click here .

The following populations are eligible, and require and employment authorization:

Application for Temporary Protected Status	Registry Applicants	Order of Supervision
Applicant for Cancellation or Removal of Suspension of Deportation	Application for Legalization under IRCA	Application for LPR under the LIFE Act

- Law does **NOT** extend coverage to Undocumented Immigrants
- Law does **NOT** extend coverage to Non-Citizens with an expired Visa
- Children do **NOT** need a SSN to apply for or enroll in Florida KidCare

Children must meet all other eligibility criteria to enroll (age, residency, income, etc.)

Children can apply for and enroll in Florida KidCare 365 days of the year - don't wait to submit your application! Insured children miss less days of school, daycare, and camp and have fewer preventable diseases.
