## **UPDATE! Mortgage Assistance Program Round 2 Still Accepting Applications**

Applications for Mortgage Assistance can be accessed at the Palm Beach County CARES for Housing site <a href="here">here</a>. Residents who received assistance in Round 1 are not eligible to apply for assistance in Round 2. Applications will be accepted until Monday, November 16, 2020 at 11:59 pm.

#### **UPDATE! CARES Act Rental & Utility Applications Deadline Extended**

The application portal for food and rental/utility assistance will remain open until midnight on November 16, 2020.

On Oct. 7, 2020, the Palm Beach County Board of County Commissioners, through its Community Services Department (CSD), resumed the acceptance of the rental and utility applications under the Coronavirus Aid, Relief and Economic Security (CARES) Act.

Eligible residents who experienced a loss of income as a direct result of COVID-19 and who are at or below 140 percent Area Median Income may apply for rental and utility assistance. Additional eligibility requirements apply, and maximum benefits are as follows:

- Rent up to \$10,000 in arrears beginning in March 2020
- Electric, water and/or gas up to \$1,200 in arrears beginning in March 2020

Residents may reapply for rental/utility assistance if they are still affected by the pandemic and have not received the maximum benefits listed above.

Also, food assistance is still available. CSD continues to accept applications for one-time food assistance. Under the CARES Act, Palm Beach County issues pre-paid debit cards to approved residents to purchase food. Only one card is issued per household, and all expenditures must be made by Dec. 30, 2020. Food assistance is based on household size. Maximum amounts are listed below.

1-2 household members: \$400
3-4 household members: \$800
5 or more household members: \$1,000

To apply for food assistance, visit www.rentalassistancepbc.org.

In order to qualify for rental, utility or food assistance, applicants must present evidence their household was affected adversely by the COVID-19 pandemic. Supporting documentation such as a most recent pay stub or filed tax return, valid government issued ID and Social Security card must be provided to prove income eligibility. # FREE Legal Representation for Palm Beach County Residents through the Rapid Response Eviction Assistance Project (RREAP)

The Palm Beach County Community Services Department (CSD) has contracted with the Legal Aid Society of Palm Beach County, Inc. and Florida Rural Legal Services, Inc. to provide county residents with free legal representation and assistance in handling landlord/tenant matters and past due payments through the Rapid Response Eviction Assistance Project (RREAP). The program is part of the CARES Act COVID-19.

Through the COVID-19 RREAP, the agencies will assist individuals who have received a three-day notice or demand for rent from their landlord, been served with an eviction lawsuit, or who need help understanding the eviction process. The services include:

- pre-suit mediation between landlords and tenants
- legal advice regarding the eviction process
- referrals for rental assistance
- preparation of responses to an eviction lawsuit
- assistance in negotiating repayment plans, and
- court representation.

The COVID-19 RREAP is designed to respond to the housing crisis created by the COVID-19 pandemic by mediating disagreements between tenants and property owners. Through this program, parties will be able to construct payment plans, temporary rent reductions, deferred payments or other creative solutions to prevent evictions and ultimately homelessness.

The program term is from Aug. 1 through Dec. 30, 2020, and participants can receive up to \$10,000 in rental assistance. Eligibility requirements for the program include:

- rental unit must be located in Palm Beach County
- tenant's income is under 140% of Area Median Income

Applicants will need documentation to qualify for the program:

- proof of U.S. Citizenship or legal residents (per CARES Act regulations)
- documentation proving hardship is directly related to the COVID-19 pandemic, such as evidence of loss of income, reduction in hours, or unemployment due to the COVID-19 pandemic that contributed to the missed rental payments, and
- an eviction notice (three-day notice or 30-day notice for CARES Act covered parties);

# County and State Orders, Actions, and Announcements

#### PALM BEACH COUNTY EXECUTIVE ORDER 20-28 ISSUED FOR PHASE 3 REOPENINGS

County Administrator Verdenia Baker has issued <u>Emergency Order 2020-028</u>, effective as of 5:00 P.M. on September 29. On September 25, Governor Ron DeSantis issued <u>Executive Order 20-244</u>, which moved all of Florida's counties into Phase 3.

### FAQs about Emergency Order 2020-08 answered <a href="here">here</a>

The County Administrator has determined that it is necessary and appropriate to repeal and replace some of the prior Palm Beach County emergency orders imposing COVID-19 related restrictions on individuals, businesses, and establishments, while making clear that certain restrictions are still imposed to curtail the spread of COVID-19. With the exception of Palm Beach County Emergency Orders Nos. 2020-012 (facial

coverings) and 2020-017 (enforcement), all prior Palm Beach County emergency orders imposing COVID-19 related restrictions on individuals, businesses, and/or establishments are hereby repealed and replaced with the Order 2020-028.

The requirements of Emergency Order 2020-012 are still in place and all individuals, businesses, and establishments must use facial coverings in all businesses and establishments; in public places where social distancing is not possible; in common areas within private communities accessible to more than one housing unit; when utilizing the Palm Tran services; and when accessing governmental buildings. In addition, businesses and establishments shall continue to ensure compliance with facial covering mandates, including establishing a process for verification of compliance upon customer entry into the business or establishment. A business's or establishment's failure to ensure said compliance may result in fines, penalties, and/or any other enforcement measures authorized by law upon those businesses or establishments. Pursuant to Governor DeSantis' Order 20-244, COVID-19 related collection of fines and penalties upon individuals is suspended.

All individuals, businesses, and establishments, shall adhere to all applicable social distancing guidelines issued by the Centers for Disease Control and Prevention (CDC). The foregoing shall apply to all persons located in all businesses and establishments, but said requirements cannot be imposed to limit restaurant capacity to less than one hundred percent of its indoor capacity at any given time.

All businesses and establishments must adhere to enhanced cleaning protocols, such as those in guidelines issued by the CDC relating to enhanced cleaning and disinfecting guidance for reopening.

## **EMERGENCY ORDER 2020-029 ISSUED EXTENDING FACIAL COVERINGS**

Considering the most current data on COVID-19 spread in Palm Beach County, Southeast Florida, and the entire State of Florida, the CDC recommendations on wearing of facial coverings, and the safe re-opening of additional businesses and public schools, the County Administrator has determined that it is necessary to extend Emergency Order Number 2020-012 until November 21.

## Palm Beach County CARES for Nonprofits Grant applications open

The Palm Beach County Board of County Commissioners has allocated up to \$4 million in emergency relief to nonprofit organizations who have been impacted by the Coronavirus (COVID-19), and has contracted with United Way of Palm Beach County to administer distribution of the funds. Funds are available as part of the Coronavirus Aid, Relief, and Economic Security (CARES) Act federal stimulus package. Qualifying nonprofit organizations may be eligible to receive a one-time grant up to \$25,000 to help them recover from the negative financial consequences resulting from the Coronavirus (COVID-19).

Applications will be reviewed, and grants awarded, on a rolling basis until funding is exhausted or the grant period closes. Eligible organizations that meet the priority criteria will be awarded grants first. Eligible organizations that do not meet the priority criteria will be considered for funding only after all of those that do meet the priority criteria are reviewed and grant award decisions have been made. One of the eligibility criteria is the nonprofit has not received more than \$25,000 in financial assistance from a state and/or federal government grant or forgivable loan established in response to COVID-19 (Example: Payroll Protection Program). One of the priority criteria is the nonprofit is a health and human service or veteran service organization. Read the grant guidelines to learn all of the eligibility and priority criteria.

#### HOMEBOUND RESIDENT TESTING

Residents eligible include homebound elderly or individuals with disabilities who are experiencing symptoms of COVID-19 and cannot leave their homes to access one of the drive-up or walk-up test collection sites. Residents who believe they are eligible for the in-home testing option should call 561-712-6400 for a pre-qualifying assessment. The testing line is open from 8:00 a.m. to 5:00 p.m. Monday through Friday.

#### Offer Testing at Your Site with Lab 24

Lab 24 is a Molecular Diagnostic Lab in South Florida currently working with the Federal Government through the Cares Act to conduct Corona (Covid-19) Virus testing Free of Charge for patients that do not have health insurance, or that are Medicare recipients. Lab 24 is FDA EUA Approved and CLIA Certified with a 48 hour turnover time.



# PALM BEACH COUNTY FUNDS A SCHOLARSHIP OPPORTUNITY FOR SCHOOL-AGE CHILDREN DURING DISTANCE LEARNING

The Palm Beach County Board of County Commissioners is providing funding through its Youth Services Department to the Early Learning Coalition of Palm Beach County to provide child care scholarships for qualifying families with school age children grades K-5 who may be participating in the School District of Palm Beach County's distant learning curriculum.

The scholarship prioritizes homeless children, children residing in families who work or attend school during the hours of the School District of Palm Beach County's distance learning and have a household income at or below 200% of federal poverty guidelines.

Additionally, Palm Beach County Youth Services procured 1,000 headsets to be supplied to child care centers allowing students to concentrate on their individual lessons in a congregate setting.

#### Meals on Wheels of the Palm Beaches

Due to COVID-19 Meals on Wheels has temporarily adjusted operations to ensure the continued health and safety of the vulnerable senior population they serve, as well volunteers many of whom are over 60 themselves. They have shifted from daily deliveries to once a week delivery of a multi-pack of frozen dinner meals along with three breakfast meals.

In addition, they have opened temporary meal service eligibility to seniors who are normally mobile and able to shop for themselves but who, due to COVID-19, are not shopping in public to minimize their exposure. Seniors receive weekly delivery of the multi-pack of meals delivered at no cost which is made possible by special grant funding.

# Nonprofit Funding

#### GREAT CHARITY CHALLENGE APPLICATIONS NOW OPEN

The event's 12th edition is committed to shifting a majority of its funding priorities towards local nonprofits who are directly supporting and assisting the most vulnerable and affected populations in Palm Beach County.

The following nonprofit categories will be eligible to be selected for funding in the main event, with a chance of receiving between \$15,000 and \$100,000: emergency health services; emergency children, family and senior services; emergency youth development and education support; emergency shelter and homeless services; emergency food support; and emergency veteran services.

The GCC board and vetting committee will also consider nonprofit organizations experiencing a critical expansion (50%+) of service delivery in response to increased demand due to COVID-19. All other categories in the application process will be eligible to be randomly selected as grant recipients, receiving between \$1,000 and \$10,000.

#### **CLARIFICATION ON FFCRA LEAVE**

The U.S. Department of Labor recently clarified that employers must grant FFCRA leave to employees who need individual full-day increments (rather than a continuous block) to care for their children whose schools are operating on an alternate day (or other hybrid-attendance) schedule. #### OSHA

OSHA is asking employers to investigate and record cases of COVID-19 that their employees acquired at work. In addition, OSHA has modified some of their language around cloth face coverings, stressing the importance of the employer duty to maintain a safe and healthy workplace. # SBA AND TREASURY ANNOUNCE SIMPLER FORGIVENESS APPLICATION FOR LOANS OF \$50,000 AND LESS

The US Small Business Administration has streamlined the PPP loan forgiveness process for forgiveness of \$50,000 or less. Users of the streamlined process are exempt from any reductions in the forgiveness amount based on reductions in full-time equivalent (FTE) employees or reductions in employee salary or wages that would otherwise apply. The borrower must still document payroll costs, the existence of obligations and service (as applicable) prior to February 15, 2020, and eligible business mortgage interest payments, business rent or lease payments, and business

utility payments, and provide that documentation with the streamlined forgiveness form to their lender.

#### TRI-RAIL INCREASES TRAINS TO JUST SHORT OF REGULAR SCHEDULE

The South Florida Regional Transportation Authority (SFRTA) announced yesterday that Tri-Rail will increase service to 46 weekday and 28 weekend trains, starting Monday, October 19, 2020.

With the latest schedule adjustment, Tri-Rail trains will be running at 92% of their normal 50 weekday/30 weekend train service. The only trains not included in the schedule are P609, P622, P629, P644 on weekdays, and P664, P669 on weekends. Trains will mostly consist of 3-car sets but the added train options can continue to help with social distancing. Facial coverings will continue to be strictly enforced onboard trains and passengers are repeatedly reminded of safety measures per CDC guidelines.
