## Vendor/ Exhibitor Application Process

Palm Beach County Parks and Recreation Department has sole discretion when choosing food and merchandise vendors or education exhibitors. The vendors and exhibitors must meet all Palm Beach County requirements to become an approved special event vendor/exhibitor. Vendors and exhibitors must submit a signed application to the Palm Beach County Parks and Recreation Department for review and approval. Once approved, vendors may only operate their service at the approved location in Glades Pioneer Park on Saturday, February 24, 2018 (during event times). The request must be approved and signed by the Department designee prior to set up. Once approved, a Special Event Vendor Certificate will be issued, to be displayed at the point of sale.

**REQUIREMENTS:**

Forms to be submitted:

1. Application- which includes contact information and a list of products or services to be offered and a description of exhibits (page 2).
2. Indemnification waiver- required for all participants (page 2).
3. Certificate of insurance (see below for requirements).
