## **AHCA requesting input from rural health on telehealth**

The Agency for Healthcare Administration has been charged through recently implemented law to survey various health care facilities throughout Florida on their use of telehealth technologies. Many have probably already received a survey on telehealth from AHCA as required by this new provision. AHCA is very interested in getting feedback from the Rural Health Community on the use of telehealth in their health care facilities. Secondly, although not required by the legislation, AHCA will be reaching out to other segments: Rural Health Centers, FQHCs, and potentially County Health Departments. Since AHCA knows that many of these groups are using telehealth to provide services, AHCA would like to get their insight even though it is not statutorily mandated.

AHCA is trying to gather as much information as possible to help the newly established Telehealth Advisory Council make informed recommendations to state leadership in the coming years. Thank you for your support.

### [Rural Farmers Market Promotes Food Security](#)

About one in seven Americans struggles with hunger, and rural communities seem to be hit especially hard. The Allegan Farmers Market is helping its low-income, senior, and other nutritionally at-risk populations gain access to Michigan-grown produce through a variety of incentives. These incentives include free transportation and Double Up Food Bucks that matches SNAP participants' spending.

### [Tom Vilsack's Lonely Fight for a 'Forgotten' Rural America](#)

Details Secretary Tom Vilsack's efforts to address the opioid epidemic, the evolution of his career, and his focus on the needs of rural America.

### [Could Diversion Programs Tested in Urban Areas Work for Rural, Too?](#)

Law Enforcement Assisted Diversion (LEAD) programs are designed to divert low-level drug offenders away from jail and prosecution and into community-based services, like treatment and housing. LEAD programs are operating in several major cities in the U.S., but a small town in North Carolina is attempting to create a rural LEAD program. Includes chart on prescription opioid and heroin deaths in North Carolina from 2008-2014.

activities to improving delivery systems and access to care. Contains rural-specific content, and information on how the states are dealing with the increased population now covered by Medicaid.
