# How Will Roe Overturn affect Florida?

Months before SCOTUS reversed R. Wade, Florida Republicans issued their own laws to limit reproductive rights. On April 14, Governor Ron De Santis Gov. Ron DeSantis publicly signed into law a 15- week abortion that shortens by more than two months the current window available to legally terminate a pregnancy. With Roe V. Wade overturned, Florida lawmakers could try to make the restrictions could more severe.

According to James Call, reporting for the Tallahassee Democrat: Republican lawmakers in both the House and Senate have defeated amendments that would have made exceptions for rape,

# ARE YOU ELECTION READY? It's Different This Time!!! Voter Roll Purges Ahead!!!

We are advising anyone who votes by mail to fill out a new Voter Registration form with BOTH their driver's license # (or permit or state ID#) AND the last 4 of their Social Security #. You will also be updating your signature.

- The ID on your Voter Registration form MUST MATCH the ID on your Vote by Mail application, or your Vote-by-Mail application will not be processed. The Supervisor of Elections is not required to notify you. So some people may be unaware that they are not signed up to vote by mail until their ballot doesn't arrive.
- expire at the end of 2022 and every EVEN year after that. You can sign up again after election day, Nov. 8, 2022. We suggest calling the Supervisor of Elections (561-656-6200) or using the on-line sign-up form @ VotePalmBeach.gov.

## LWV Fights SCOTUS Ruling that Weakens Gun Safety Laws

SCOTUS has ruled that a New York law restricting certain individuals from carrying concealed weapons in public is unconstitutional, effectively weakening gun safety laws around the country.

The League of Women Voters of Florida, along side League of Women Voters of the U.S. and League Of Women Voters of NYS, filed an amicus brief in support of NY's law. The LWV of Florida joined the brief in interest of protecting their efforts to allow counties to place additional protective restrictions on voting locations and prevent voter intimidation.

"Floridians know the devastating effects of gun violence in public places, and today's Supreme Court decision will threaten the safety of our communities," said Cecile Scoon, president of the League of Women Voters of

# Majority of Americans want Congress to pass more gun policy legislation

According to a new report from the Pew Research Center, "Americans are largely supportive of the new bi partisan gun law passed by Congress and signed into law by President Joe Biden on June 25. Nearly two-thirds of U.S. adults (64%) approve of the new gun law, including 32% who strongly approve

Just 21% say they disapprove of the law, including 11% who *strongly* disapprove; 15% are not sure."
