FLORIDA ANNOUNCED AS THE FIRST STATE IN THE SUN BELT TO RECEIVE AGE-FRIENDLY STATE DESIGNATION

On Tuesday, April 23, Governor Ron DeSantis, DOEA Secretary Richard Prudom, and AARP CEO Jo Ann Jenkins announced Florida's designations as an Age-Friendly State by AARP. Florida is the largest state to achieve this designation and the only one in the entire Sun Belt.

"In Florida, we are taking tangible steps to make our state more livable for residents of all ages – especially our senior population," said Governor DeSantis. "As our state continues to grow, we must ensure that we do all that we can to meet the needs of our residents. I am proud that Florida is leading by becoming

the largest state to commit to this important effort."

"We are proud to receive the significant designation as an Age-Friendly State," said Richard Prudom, Secretary for the Florida Department of Elder Affairs. "Throughout the next decade, the population of older Floridians is expected to increase by nearly 40 percent, so it is essential that communities are prepared. Our efforts continue as we work to make Florida a place where we can all live and live well."

"This designation opens the way for important partnerships in many parts of state, city and county government, and in the

private sector, to make Florida an even better place to live for people of every age," said Jeff Johnson, AARP's Florida State Director. "For the more than 8 million Floridians age 50-plus and the 2.8 million AARP members statewide, this is a big step forward."

Florida's designation as an Age-Friendly State demonstrates Florida's commitment to building Livable Communities that enrich the lives of people of all ages. Member states develop and implement plans that address any or all of the eight Age-Friendly

domains: Transportation, Housing, Public Spaces, Respect and Social Inclusion, Civic Participation and Employment, Social Participation, Community and Health Services, and Communication and Information.



JUNE IS ELDER ABUSE AWARENESS MONTH:

June 15th is Florida's Elder Abuse Awareness Day. The issuance of a yearly proclamation serves as a call to action for all Floridians to work together to prevent elder abuse. The prevention of elder abuse means that our most valuable resource, elders, are safe from neglect, exploitation, and abuse.

ADDRESSING THE PUBLIC HEALTH NEEDS OF OLDER FLORIDIANS

The Florida Department of Health is pleased to announce that 37 counties (see map below - counties in green) are participating in the Florida Age-Friendly Public Health Learning and Action Network, facilitated by Trust for America's Health (TFAH) with generous funding from The John A. Hartford Foundation. DOH and TFAH aim to identify and enhance the role of public health in improving the health and well-being of the older adults in Florida.

In October 2017, TFAH brought together 30 experts in public health, aging, research, and policy in Florida to explore how public health could contribute to the health and well-being of older adults. Convening participants developed a [Framework for Creating an Age-Friendly Public Health System](#) to advance public

health's role in addressing the challenges and opportunities of an aging society at the local, state and national levels.

Through the Florida Age-Friendly Public Health Learning and Action Network, DOH has been working with the Florida Department of Elder Affairs and community partners to identify priority health issues among our older adults. Each county health department will receive tools, training resources, and technical assistance based on the particular needs of their community. TFAH will be sharing the results of this initiative with public health stakeholders and policymakers across the country. This collaborative effort will help Florida meet the unique public health needs of older adults.



CITY OF ORLANDO WAS THE 1ST COMMUNITY TO JOIN IN 2019!

The Network of Age-Friendly Communities is currently at 26 enrolled communities, and 3 communities have an approved action plan! The AARP Network of Age-Friendly Communities is a collection of communities that have committed to actively work together to make their town, city, or county livable for people of all ages. The network helps participating communities become great places by adopting such features as walkable streets, better housing, transportation options, access to key services, and opportunities for residents to participate in community activities. The Department of Elder Affairs Staff attended the 6th annual Safe Streets Summit in Miami. This event started back in 2013 with only 50 people, and this year they had over 500 in attendance. DEMENTIA CARE AND CURE INITIATIVE



TALLAHASSEE

The Tallahassee DCCI Task Force has been providing free dementia sensitivity training to local restaurants in Leon County. So far, five (5) restaurants have become Dementia-Caring, and they are:

- Wharf Casual Seafood (Mahan & Bannerman locations)

FT. MYERS

The Ft. Myers DCCI Task Force will be honoring the Cape Coral Police Department in a DCCI Decal Ceremony on Wednesday, May 8th. The Cape Coral Police Department became Dementia-Caring after taking part in a weeklong series of dementia sensitivity training offered by the Ft. Myers Task Force, with over 200 officers and police personnel becoming trained.

GAINESVILLE

In partnership with a local educational video production company, the Gainesville DCCI Task Force created a video version of the DCCI dementia sensitivity training to be used throughout their service area. The two leaders of this Task Force facilitate the video and guide viewers through a tour of DCCI with an overview of dementia, signs and symptoms to look for, communication techniques, and local resources.

BREVARD

The Brevard DCCI Task Force held an art class for people living with dementia and their care partners to design the artwork for their Task Force decal. An anonymous vote by Task Force members selected the winning design, which was painted by a man living with Alzheimer's disease. (pictured right)



JACKSONVILLE

The Training and Education subcommittee of the Jacksonville DCCI Task Force is working on piloting a program at a local hospital to distribute community resource toolkits upon discharge. These toolkits will be for individuals living with or recently diagnosed with dementia and will contain information about local resources for the person with dementia and their care partner(s).

TAMPA

The Tampa DCCI Task Force and Hillsborough County Commissioner Murman will be presenting the Hillsborough Board of County Commissioners with a proclamation announcing the month of June 2019 as "Dementia Care and Cure Initiative Community Month". This presentation will take place on Thursday, June 27th during the Commission's Quarterly Awards Ceremony.
