Mayor's Forum on Opioids

This summer, I hosted a forum on the opioid crisis. During the forum, we discussed the progress on Palm Beach County's Opioid Response Plan and the collective efforts of stakeholders throughout the County to address the opioid epidemic and other substance use disorders. We also discussed continuing challenges related to the epidemic, the latest treatment and recovery trends, and ways to galvanize stakeholders around further action steps to this complex challenge.


The County Medical Examiner is estimating that there will be 399 opioid-related overdose deaths deaths this year, which would be a 38% drop from the 647 in 2017, which would be the first decrease in local deaths since the emergency started. While this is good news, there are still too many people losing their lives. I am not convinced yet that we have had a significant reduction in overdoses; the reduction in deaths may be attributed to a wider availability of Narcan. That's why we must remain vigilant and continue the work we're doing.

Special thanks goes to John Hulick, the County's new Substance Abuse Program Manager, for his hard work in organizing and moderating the forum, and the panelists who shared their expertise and updates on their work to address the

crisis.

And I am especially thankful to everyone who attended. Your dedication in helping fight this battle and your everyday work to save lives is so appreciated!





FY 19 Budget

The Board of County Commissioners recently approved a \$4.8 billion budget for Fiscal Year 2019. The millage rate has been set at 4.78, the same as FY18.

I am happy to share that the budget includes six additional firefighters to be added to Station 22, which serves the Acreage. I've pushed for this staffing increase at Station 22 for years, so this is an important victory for public safety in District 6. Construction for the new Station 22 is expected to begin by the end of this year.

Finally, the budget also includes \$2 million to continue our response against the opioid epidemic.

Garbage Collection Update

Thank you to everyone who shared their concerns over the changes that had been proposed for the new Solid Waste Authority garbage collection contract. After carefully considering all of your comments, I voted with the majority of my county commissioners to keep trash pickup at two times per week. We also approved going to a semiautomatic/automatic collection method instead of manual, which will improve worker safety. Yard waste pickup will also remain at 6 cubic yards. These conditions will be part of a new seven-year contract that garbage haulers will be submitting bids on soon.

Orange Bowl Field Groundbreaking

On July 11, Palm Beach County and the Orange Bowl Committee broke ground on a \$3 million renovation to the football stadium and field located at Glades Pioneer Park. The field will also get a new name: Orange Bowl Field at Glade Pioneer Park. Renovations include a synthetic turf field and maintenance, an entry monument, fencing, walkways, signage, and an electric scoreboard.

Thank you to everyone who made this happen! It will truly make a difference in the lives of many youth to have such an enriched athletic environment!

Text to 911

On June 25, Palm Beach County announced that hearing and/or speech impaired members of the community, or those in a situation where it is too dangerous to dial 9-1-1, now have another option to request help in an emergency – Text to 9-1-1.

The benefits to the public are significant, especially in cases when the caller cannot communicate verbally. Examples of Text to 9-1-1 scenarios include an individual who is deaf, hard of hearing, or has a speech disability; someone who is in a situation where it is not safe to place a voice call to 9-1-1; or a medical emergency that renders the person incapable of speech.

Text to 9-1-1 guidelines:

- "Call if you can Text if you can't."
- Do not include anyone other than "911" in the Text message. If you include anyone else on your text, it may not be received.
- Always provide your location. Text to 9-1-1 location information is not equal to
 current
 wireless-location
 technology.
- When communicating with 911, use plain language. No abbreviations, shortcuts or slang.
- Photos and videos cannot be sent to 911 at this time.
- Language interpretation is not currently available when texting 9-1-1.
- As with all text messages, messages to 911 may take longer to receive, may
 get out of order, or may not be received at all.
- Text to 9-1-1 is an enhancement to the existing 9-1-1 system and is not intended to replace traditional emergency voice calls. Text Messages are routed to the appropriate Palm Beach County 911 center, in a designated queue.



S.W.A.G. Graduation

On August 7, the Village of Wellington hosted a graduation ceremony for the students who participated in the S.W.A.G. internship, short for Students Working to Achieve Greatness. This internship program encourages students ages 16 - 18 to complete high school, acquire life-skills, pursue advance education, and assist with attaining meaningful and gainful employment for teenagers who face barriers that place them at risk. In addition, the program provides the students with educational counseling, developmental skills training and stipends for summer internships.

Our S.W.A.G. intern, Madison Gay, did a phenomenal job this summer! She is looking forward to a career as a firefighter, and we know she will be an incredible asset to the community.



Glades Operation Roadblock Tabletop Exercise

On August 16, Mayor McKinlay participated in a tabletop exercise organized by the Treasure Coast Local Emergency Planning Council that revolved aground emergency response coordination for the Glades region. Discussion focused around issues such as hazmat decontamination, victim transport, on-scene incident command and control, and communications with impacted communities. In addition, the ability of resources to reach affected rural areas if essential roadways were compromised was also discussed as a paramount issue. During the meeting several agencies and organizations, such as Florida Department of Transportation,

Palm Beach County Sheriff's Office, Palm Beach County Fire Rescue, Department of Health, Palm Beach County Emergency Operations Center, and Lakeside Hospital, were named as playing a significant role in support to first responders and deemed essential to the overall goal of effective and efficient emergency preparedness and response.

Recent BCC News

Forbes – announced that Palm Beach County was named to *Forbes*magazine's list of America's Best Employers. *Forbes* selected 500 large companies in the U.S. with 5,000 or more employees, and Palm Beach County placed No. 243 overall. The county also ranked No. 10 nationally among large government services employers.

School security – approved a budget amendment of \$223,200 for law enforcement services provided by the Palm Beach County Sheriff's Office to the Palm Beach County School Board. The funding pays for 10 deputies per day for campus security on days to be designated by the School Board.

Tourist development – approved on preliminary reading and to advertise for public hearing on October 16 an ordinance amending the Tourist Development Ordinance to require hosting platforms and booking services to verify that a host's residential unit is registered with the Tax Collector's Office and has both a business tax receipt and a tourist development tax account prior to advertising the unit as a short-term rental. The amendment also requires short-term rentals to retain certain records

and authorizes the Tax Collector's Office to issue administrative subpoenas to obtain records, and provides for civil and administrative penalties.

Project Paper – conceptually approved a property tax exemption up to \$478,873 over a ten-year period for Project Paper. The company is considering relocating its Florida-based manufacturing business to Belle Glade. The company will invest \$33.7 million to purchase land and construct and equip a 400,000-square-foot facility, creating 40 new jobs over a two-year period and retaining 150 jobs at an annualized average wage of \$34,999. The estimated five-year local economic impact is \$108.5 million.
