# FEDERAL GRANTS

# **Federal Surplus Personal Property Donation Program**

**Purpose/Description:** To provide state and other public agencies with federal surplus personal property no longer needed by the federal government. A variety of surplus property may be available. Eligible applicants include state and local government agencies and nonprofit organizations offering senior services, educational and public health activities, and activities that provide food, shelter, or support services to homeless or impoverished people.

**Eligible Applicants:** State and local government agencies and public organizations, generally including:

- Public agencies, including Indian tribes, bands, groups, pueblos, or communities located on state reservations
- Nonprofit educational and public health agencies, including:
  - Medical institutions
  - o Hospitals, clinics, and health centers
  - o Historic light stations
  - Drug abuse treatment centers
  - Schools, colleges, and universities, and schools for persons with mental or physical disabilities
  - Child care centers
  - o Educational radio and television stations licensed by the Federal Communication Commission
  - Museums attended by the public
  - o Free libraries
- Nonprofit and public programs for the elderly, including:
  - Adult day care
  - Social, transportation, nutrition, and legal services

- Land or other real property
- Certain naval vessels
- Records of the federal government

#### **TD Charitable Foundation Grants**

**Purpose/Description:** To support organizations creating meaningful change and improvement in the communities where the funding agency does business and where its employees live. The funding agency is interested in collaborative programs, as well as programs that bring new dollars into the community. Supported projects should focus on the following areas:

- <u>Affordable housing</u>: including community revitalization and the preservation and development of affordable housing

Whenever possible, requested awards should be programmatic in nature and focus, and add value to the scope of services offered by the applicant organization.

**Eligible Applicants:** 501(c)(3) nonprofit organizations Public schools Qualified state or local governmental entities.

#### **Microsoft Software Donations**

**Purpose/Description:** To provide licenses, subscriptions, and services for Microsoft software products to nonprofit organizations that have a mission to benefit the local community. This program provides free software and services, including Office 365, Power BI, and others; and upgrades to Windows 10 or Enterprise with up to 50 licenses. Supported organizations have a mission that include:

- Providing relief to the poor
- Advancing education
- Improving social welfare
- Preserving culture
- Preserving or restoring the environment
- Promoting human rights
- Establishing a civil society

**Eligible Applicants:** Eligible applicants are 501(c)(3) nonprofit organizations that have a mission to benefit the local community.

Public libraries without status as a charitable organization may be considered eligible if requesting on-premises software donations where software will be made accessible to the general public. The following entities are <u>not</u> eligible to apply:

- Nonprofit organizations that have not obtained recognized charitable status
- Governmental organizations or agencies, including international governmental organizations and United Nations entities
- Colleges and universities
- · Schools, including nonprofit schools
- Professional, commerce, and trade associations
- Political, labor, and fraternal organizations

**Deadline:** Requests are accepted on a rolling basis. Prior to submitting a request, applicants must complete registration and obtain a validation token online at <a href="mailto:app.ngok.techsoupglobal.org/Default">app.ngok.techsoupglobal.org/Default</a>.

Requests must be submitted online at <u>aka.ms/productDonationPortal</u>.

**Range/Average of Assistance:** Rather than providing monetary awards, this program provides licenses, subscriptions, and services for Microsoft software products.

This program will  $\underline{not}$  support:

- Events, tables, exhibitions, or performances
- Fundraising events such as luncheons, dinners, walks, runs, or sports tournaments
- Refurbishers that will be installing the donated software on refurbished computers to be distributed or donated

**Other Information:** Health care organizations included in the Microsoft Health Program are generally <u>ineligible</u> to apply. These ineligible entities include hospitals, health care networks, health plans, ambulatory/outpatient health care organizations, nursing homes/assisted living, home health care, and health research organizations and laboratories. However, select health care organizations included in the Microsoft Health Program may be eligible to apply if they are the following types of independent nonprofit organizations: community, behavioral and women's health clinics, hospices, emergency services, and blood, tissue, and organ banks.

**Purpose/Description:** To support projects that promote gender, racial, and economic justice. Projects must be led by and benefit women and girls, particularly those from vulnerable communities. The foundation supports projects designed and implemented by women and girls, and applicants that reflect the diversity of the community served in both their leadership and organization.

Funding is provided to applicants with limited financial access for projects and/or applicants that have encountered funding obstacles. First-time applicants and small and start-up organizations are strongly encouraged to apply.

Funding is available for projects in the following areas:

- Advocacy and public policy
- Domestic violence and sexual assault
- Education
- Employment and economic development
- Girls
- Housing and homelessness
- Leadership development
- Sexual orientation

**Eligible Applicants:** 501(c)(3) nonprofit organizations, or organizations that designate a 501(c)(3) fiscal sponsor. Applicants must have an organizational budget of under \$150,000. Small and start-up organizations are strongly encouraged to apply. Priority will be given to eligible first-time applicants.

Applicants may submit only one proposal per funding cycle. Proposals involving more than one project will <u>not</u> be considered.

The following entities are <u>not</u> eligible to apply:

- Organizations with a total income of \$150,000 or more
- Religious and/or faith-based institutions
- Public or private educational institutions
- Local, state, and national governmental agencies
- For-profit businesses
