[Big Battles Over Farm And Food Policies May Be Brewing As Trump Era Begins](#) — NPR, The Salt, December 28, 2016

The president-elect hasn't yet nominated someone to head the Department of Agriculture or the Food and Drug Administration. The Farm Bill, which funds both SNAP and farm subsidies, is due to be renegotiated by the end of 2018. Some lawmakers may renew their previously unsuccessful efforts to separate the farm-related provisions and the nutrition programs into separate bills. There could also be attempts to roll back parts of the school meal reforms made during the Obama administration.
